**-:NOTICE:-**

All the UG and PG Students of DUVASU, Mathura are hereby instructed not to indulge in ragging of junior students. Ragging is banned by law and as per rules of University Grant Commission (UGC). If anybody is found to be indulging appears to be involved in ragging will not be spared. No enquiry/clarification will be asked from the indulged/appeared to be indulged students. He/She will be dropped from the University as per Supreme Court orders.

Following acts will be accounted as ragging:

- 1- Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other students.
- 2- Indulging in any rowdy or indisciplined activities by any student or students which causes or is likely to causes annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- 3- Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame or torment or embarrassment so as to adversely affect the physique of such fresher or any other student.
- 4- Any act by a senior student that prevent, disrupts or disturbs the regular academic activity of any other students or fresher.
- 5- Exploiting the services of the fresher or any other student for completing any task including academic task assigned to an individual or a group of students.
- 6- And act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
- 7- Any act of physical abuse including all variants of it; sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gesture, causing bodily harm or any other danger to health or person.
- 8- Any act or abuse by spoken words, emails, posts, public insults which would also indulge deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- 9- Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student's over any fresher or any other student.
