ABOUT THE UNIVERSITY

U.P. Pandit Deen Dayal Upadhyaya Pashu Chikitsa Vigyan Vishwavidyalaya Evam Go-Anusandhan Sansthan, Mathura came into existence on Oct. 25, 2001, by an Act of Govt. of Uttar Pradesh (Act No. 27 of 2001).

Brij area is known since time immemorial for Lord Krishna and its animal wealth, particularly cows. There are large numbers of Gau-shalas in and around Mathura having hundreds and thousands of cows. The whole of Brij Kshetra is famous for its milk and milk products (doodh, dahi, makhan, pera etc.). Recognizing the importance of livestock of this area, the erstwhile U.P. College of Veterinary Science and Animal Husbandry was established in Mathura by Govt. of U.P. in 1947. It was the first Veterinary College in Asia to confer the degree in Veterinary Science. Ever since the establishment of this College, it has contributed significantly not only in terms of number of graduates and post-graduates of high scholastic order, but also quality research of national and international standards. This College has a glorious past and the distinction of having its alumni holding high positions in India and abroad as teachers, research workers, policy makers, consultants and administrators. In the year 1975, this college was made a constituent College of the newly established C.S Azad University of Agriculture and Technology, Kanpur.

However, keeping in view the requirement of trained and competent manpower in the field of Veterinary Science, Animal Husbandry, Fisheries and other allied disciplines and also to give a fulfill to research on different aspects of cattle production, Govt. of Uttar Pradesh established U. P. Pandit Deen Dayal Upadhyaya Pashu Chikitsa Vigyan Vishwavidyalaya Evam Go-Anusandhan Sansthan, Mathura, the fourth Veterinary University in the country and the Veterinary College Mathura became the first constituent College of the University. The University is located on the Mathura - Agra road and is about 5km from Mathura Junction railway station and 4 km from new bus stand. The main campus of the University is spread over a vast land area of 782.32 acres in Mathura Cantt and about 1400 acres at Madhuri kund, about 20 km away from the main campus.

The objectives and mandate of the University are:

- (i) To impart quality education in Veterinary and allied sciences;
- (ii) To undertake need-based and basic research; and
- (iii) To provide extension services to disseminate the research findings and knowledge to farmers and livestock owners.

Presently the university has following colleges:

1. College of Veterinary Science and Animal Husbandry
2. College of Biotechnology

The Go-Anusandhan Sansthan is a unique feature of this University and first of its kind in India. It would provide latest facilities for research on various aspects related to cattle, its products and by-products.

College of Biotechnology (On Self Finance Scheme):

The College of Biotechnology was started in 2010 under self-finance scheme with the objective of imparting quality education in the field of biotechnology and undertake research in Biotechnology and allied subjects and generate competent human resource. The College has competent faculty to run the undergraduate and post graduate programmes. The College is housed in a newly constructed college building and is well equipped with the necessary facilities for teaching and research. Availability of excellent laboratory facilities and experienced faculty of College of Veterinary Science and Animal Husbandry is the added strength of the College of Biotechnology. The graduates of this college have been selected to different National Institutes of the country for their higher studies. The University has signed Memorandum of Understanding (MoU) with Central Institute for Research on Goats (CIRG), Makhdoom, Indian Veterinary Research Institute (IVRI), Izatnagar and National Dairy Research Institute (NDRI), Karnal, NRC Meat, Hyderabad and NIAH, Baghpat. These MoUs with the National institutes have further enhanced the research and education opportunities and capabilities through their experienced faculty and laboratory facilities. The college has been reconstituted as per recommendations of Vth Dean's Committee report of the ICAR and will have five departments:

- i) Plant Biotechnology
- ii) Animal Biotechnology
- iii) Microbial and Environmental Biotechnology
- iv) Bioinformatics
- v) Basic Sciences

The college has been offering B.Sc.(Hons.) Biotechnology/Industrial Microbiology (6 semesters), however, as per the Vth Dean Committee report and subsequent discussion, necessary modifications have been done in course programme and from academic year 2023-2024 the College will be offering following academic programme:

- (i) Bachelor of Technology (Biotechnology): 4 years degree programme as per ICAR.
- (ii) MSc./MVSc./M.Tech (Biotechnology): Minimum 4 Semesters as per BSMA regulations of Indian Council of Agricultural Research (ICAR). The candidates with basic degree of BSc will be awarded MSc, while those with basic degree of BVSc and AH will be awarded MVSc and those with B. Tech will be awarded M.Tech.
- (iii) PhD (Biotechnology): Minimum 6 Semesters as per BSMA regulations of Indian Council of Agricultural Research (ICAR)

Mandate and objectives of college are

1. To undertake teaching, research and training in various facets of biotechnology and allied sciences.
2. To conduct basic, strategic, applied and anticipatory research in the field of Biotechnology and allied sciences for the benefit of farmers, students and local people
3. To foster and support effective education and research in Biotechnology.
4. To facilitate over all character building through a holistic approach including the curricular, extra-curricular and co-curricular activities.
5. To develop new and novel value added products, processes, platform technologies and patents.
6. To promote establishment of Biotechnology based entrepreneurship.

University Students' Amenities and Other Details:

Facilities for indoor and outdoor games are available for students. There is a large playground in front of the main building of Veterinary College for outdoor games like cricket, hockey, football, volley ball, lawn-tennis, kabaddi, kho-kho. A part from this, gymnasium with indoor facilities is available at campus. A large badminton hall and squash court is also available. University organizes annual sports meet along with the cultural programmes. All the sport events are co-ordinated by Staff Counsellors. Dean Students Welfare is the overall Co-ordinating Officer and In-charge of all such programmes. Extra-curricular

activities such as debates, declamation, quiz, essay writing competition and cultural activities are also organized from time to time.

Sports: Facilities for indoor and outdoor games are provided to the students. There is a large play ground in front of the main building of Veterinary College for outdoor games like cricket, hockey, foot-ball, volley-ball, kabaddi, kho-kho etc. and various other athletic events. A new Gymnasium building of the University with excellent indoor facilities is also available at the campus. A large indoor badminton hall is also available in one of the hostels as round the year facility for indoor game (s). The University organizes annual sports meet along with the cultural programmes. All the sport events are guided and managed under the guidance of Staff Counselors and President Games and Sports is the overall Coordinating officer In-charge of all such programmes.

Extra Curricular Activities: Extra-curricular activities such as debates, declamation quiz, essay writing competition and cultural activities are arranged from time to time under the leadership of a Student Cultural Secretary and Cultural Counselor.

Cafeteria /Canteen: Cafeteria / Canteen are available to meet out the demand of student and staff of the University.

University Library: University library is housed in a three storied building with large number of books and relevant Indian and foreign journals. Library also has the facilities of photocopy machine and computers with internet connection. The library remains open from 10.00 A.M. to 5.00 P.M. A separate book bank also exists in the library with additional facility for the students of the weaker sections of the society.

Bank and ATM: Indian Overseas Bank with ATM facility and sub post Office facilities are also available in the University Campus.

Students Welfare: The Students Welfare setup in the university looks after the basic amenities for students and ensures facilities and services for personality development and for inculcating leadership qualities in them. Special emphasis is laid on discipline. Students effectively participate in the management of hostels, mess, games and sports, cultural and literary activities and other functions of the university from time to time cultural and literary activities and other functions of the university from time to time.

Hostels: The University has eleven (6 Boys hostels & 5 Girls hostels) well-ventilated, neat and clean hostels for accommodating the students. Hostels are provided with Wi-Fi internet connectivity. Each hostel has common room facility with coloured television, newspapers and magazines. Indoor game facilities for Table-Tennis, Carom etc. are also available. Mess facility is available in all the University hostels. The hostels are managed by hostel wardens under the supervision of Dean Students Welfare (DSW). **Hostel allotment is done as per the availability**

NCC and NSS: NCC/NSS is mandatory for each and every student of B.V.Sc. & A.H. programme as per the course-curriculum of Veterinary Council of India. The students have to compulsorily join 1 UP R & V Sqn. NCC or NSS. In addition to routine activities of NCC and NSS, they also learn horse riding and participate in Republic day parade and various national level equestrian events. NCC cadets of R & V squadron have been bringing laurels to the University in national level events.

Communication Skills and Personality Development Programme: University engages outside experts for improving the communication skills of students and for their overall personality development.

Award of Medals:

M.Sc./M.V.Sc./M.Tech. (Biotechnology): The meritorious students are awarded University Gold and/or Silver Medals as per University rules.

Facilities in College of Biotechnology :

Instrumentation and Molecular biology lab:

Molecular biology is the aspect of biology that deals with the molecular basis of biological activity. This aspect of science is related with other areas of biology, chemistry, genetics and biochemistry. Mostly, molecular biology chiefly covers interactions between the various systems of a cell, namely between the different types of DNA, RNA and protein biosynthesis, and how these interactions are regulated.

Microbiology Lab:

A microbiology laboratory is a laboratory devoted to the culturing, examination, and identification of microorganisms including bacteria, fungi, yeasts, etc.

Tissue Culture Lab:

Tissue culture is the most applied biotechnology tool and its establishment is vital for the application of various techniques. By means of definition, plant or animal

tissue culture is the growth or maintenance of cells, tissues or organs or whole (plant or animal) on a nutrient culture medium under aseptic conditions in-vitro.

M.Sc./M.Tech/M.V.Sc.(Biotechnology)

M.Sc./M.Tech/M.V.Sc.(Biotechnology) aims to develop specialization in various diversified areas of biotechnology and its application to medicine, agriculture, environment, functional food and animal science etc.

The curriculum imparts training in both fundamental and applied aspects of biotechnology. Each subject is adequately supported by applied practical conducted in well equipped laboratories in the area of Biotechnology, Animal Biotechnology and Immunology. The programme has a well conceived curriculum so as to fulfill the requirement for higher academic pursuits in Biotechnology.

Ph.D. in Biotechnology:

PhD Biotechnology aims to develop hard core specialization in a single area of Biotechnology as applicable to medicine, agriculture, environment, functional food and animal sciences.

Career Prospects

The curriculum imparts training in both theory and research aspects of biotechnology. Each research project is adequately supported by trained faculty and state of the art laboratories in the area of Biotechnology, Animal Biotechnology, Virology and Immunology and Embryo biotechnology. The programme has a well constructed curriculum so as to fulfill requirements for higher academic pursuits in Biotechnology.

- OGPA or equivalent percentage of marks for SC/ST/PH category as per the guidelines of ICAR. Conversion formula for OGPA calculation shall be of the respective university and of the same year in which the candidate has obtained degree.
- For Ph.D. programme, candidates who qualify SRF of ICAR and in-service candidates of other SAUs / SVUs / ICAR and of DUVASU. Their seats shall be over and above the seats shown above in table.
- There is no age limit for the candidates seeking admission to Masters and Doctorate programmes.
- Mere application by a candidate and call for counseling does not amount to admission in the PG programmes.
- The reservation policy of Uttar Pradesh Government and the 100 point roster will be followed on the total number of seats for Masters (Biotechnology) programme.
- The vacant seats will be converted into UR Category.
- The candidates once allotted a seat in any programme of the University shall be required to deposit the fees on the date of admission. If he/she fails to deposit the fee after allotment of a seat, seat shall stand cancelled automatically and the same will be allotted to next candidate according to merit.

Method of Selection:

1. The merit list will be communicated through University website. No separate counseling letters will be issued.
2. The admission shall be made strictly on the basis of marks obtained in the qualifying examination.

If the merit found to be similar in that case following criteria will be adopted to decide the merit:

- a) Aggregate percentage of marks in lower examination i.e. intermediate for Master's program and graduation for PhD program.
- b) Aggregate percentage of marks in the subsequent lower exam
