- (iv) The original documents related to the candidature of the candidate shall be verified by the respective allotted Veterinary College/University at the time of reporting for admission to B.V.Sc. & A.H course under 15% All India quota.
- (v) Security deposit collected during Mop-up round shall be refunded to the candidates upon reporting to the College. The Refund will be sent to the same account from which it was paid. No refund shall be given to non-reporting candidates.
