The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

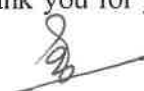

7.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

8. Part payment or part supply orders will not be accepted. The payment will be made immediately after delivery of

Goods/Setup/installation/training/assignment/physical & Functional verification as per signed up/award of contract.

9. The necessary catalogue, leaf lets, operational manual or any other printed material related to goods/material should be provided during completion of contract.
10. Normal commercial warranty/ guarantee shall be applicable to the supplied goods.
11. The rates/prices should be FOR, DUVASU, Mathura (UP) India. All leakages-breakage and losses in transit including shortages, if any will be borne by the firm/supplier.
