- d) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- e) The Prices shall be quoted in Indian Rupees only.

4. Each bidder shall submit only one quotation.

5. **Validity of Quotation**

Quotation shall remain valid for a period not less than 15 days after the deadline date specified for submission.

6. **Evaluation of Quotations**

The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

- a) are properly signed ;and
- b) Conform to the terms and conditions, and specifications.

The Quotations would be evaluated for all the items together.

GST in connection with sale of goods shall not be taken into account in evaluation.

7. **Award of contract**

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

7.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

7.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

8. Part payment or part supply orders will not be accepted. The payment will be made immediately after delivery of



Goods/Setup/installation/training/assignment/physical & Functional verification as per signed up/award of contract.

9. The necessary catalogue, leaflets, operational manual or any other printed material related to goods/material should be provided during completion of contract.
10. Normal commercial warranty/guarantee shall be applicable to the supplied goods.
11. The rates/prices should be FOR, DUVASU, Mathura (UP) India. All leakages-breakage and losses in transit including shortages, if any will be borne by the firm/supplier.
12. The firm should provide proof of GST registration no. / Tin no. / PAN no. and all legislative documents/Experience related documents required.
