GST in connection with sale of goods shall not be taken into account in evaluation.

7. Award of contract

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- 7.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- 72 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchaseorder.
- **8.** Part payment or part supply orders will not be accepted. The payment will be made immediately after delivery of Goods/Setup/installation/training/assignment as per signed up/award of contract.
- 9. Thenecessarycatalogue,leaflets,operationalmanualoranyotherprintedmaterialrelate dto goods/material should be provided during completion of contract.
- 10. The product should carry 1 year comprehensive warranty against manufacturing defects and an undertaking on the company letter head should be submitted by the bidder with quotation.

- 11. The rates/prices should be F.O.R., DUVASU, Mathura (UP) India. All leakages-breakage and losses in transit including shortages, if any will be borne by the firm/supplier. Offer should clearly mention the locations for which rates are quoted.
- 12. The firm should provide proof of GST registration no. / Tin no. / PAN no. and all legislative documents required as per world bank/ICAR New Delhiprocedure.
