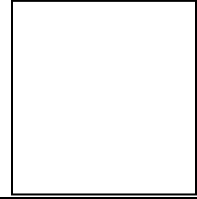

Terms & Conditions.

1. Candidates are advised to be present at least one hour before commencement of interview for necessary formalities.
2. The Candidate should produce Original copies of all certificates and other documentary proof at the time of interview.
3. The engagement on the teaching associate posts are purely temporary basis and will be initially for 06 months; however it may continue further or can even be terminated by the University Authorities at any time without any prior notice.
4. Selected candidate has to provide an affidavit on Rs. 100/- stamp that he will leave only with a prior notice of one month otherwise his/her last month's emolument will not be paid.
5. No TA/DA will be provided for appearing in the interview.
6. The Teaching Associate may also leave the assignment, on their own desire, by giving one month prior notice.
7. **Age** -The Upper age limit for Teaching Associate will be 40 years for men & women
8. **Discipline**- Since the Teaching Associate working in the diploma courses handle students, laboratory, equipments and other biological materials etc., they are required to show satisfactory performance of duties and maintain discipline as per the code of conduct and prevailing rules of the university. Non-maintenance of the discipline or failure to perform the duties assigned will make the Teaching Associate liable for termination.
9. **Leave** - Since the Teaching Associate do not have status of regular employees they are not entitled for any regular leave. However Teaching Associate is allowed to avail Casual Leave (CL) and Restricted Holidays as per rules of the University and as issued from time to time.
