3. The engagement on the teaching associate posts are purely temporary basis and will be initially for 06 months; however it may continue further or can even be terminated by the University Authorities at any time without any prior notice.
4. Selected candidate has to provide an affidavit on Rs. 100/- stamp that he will leave only with a prior notice of one month otherwise his/her last month's emolument will not be paid.
5. No TA/DA will be provided for appearing in the interview.
6. The Teaching Associate may also leave the assignment, on their own desire, by giving one month prior notice.
7. **Age** -The Upper age limit for Teaching Associate will be 40 years for men & women
8. **Discipline**- Since the Teaching Associate working in the diploma courses handle students, laboratory, equipments and other biological materials etc., they are required to show satisfactory performance of duties and maintain discipline as per the code of conduct and prevailing rules of the university.
