### ABOUT THE UNIVERSITY

Uttar Pradesh Pandit Deen Dayal Upadhyaya Pashu Chikitsa Vigyan Vishwavidyalaya Evam Go-Anusandhan Sansthan (DUVASU), Mathura was established by Government of Uttar Pradesh through the Act No. 27 of 2001 on October 25, 2001, by carving out all the units of College of Veterinary Science and Animal Husbandry from C.S. Azad University of Agriculture & Technology, Kanpur. The College of Veterinary Science and Animal Husbandry, Mathura became its first constituent college. The parent institution of this University had the distinction of being the first Veterinary College set up before independence of India on 16<sup>th</sup> January 1947. It was the first Veterinary College in Asia to start with degree programme in Veterinary Science and to start M.V.Sc/M.Sc degree programmes in various disciplines of Veterinary and Animal Sciences in 1951 and thereafter started Ph.D. degree programmes.

The University has been named after a great visionary and statesman - Pt. Deen Dayal Upadhyaya, whose native place is in close proximity to Mathura, propounded the philosophy of "Integrated Humanism". He emphasized that the modern advances in science and technology should be oriented to uplift the economy of rural India and farming community. He was a connoisseur of traditional wisdom of Indian thinkers and a great supporter of natural resource management in crop and animal husbandry.

The mandate of the University is to (a) impart quality education in Veterinary and allied sciences (b) undertake need-based and basic research and (c) provide extension services to disseminate the research findings and knowledge to farmers and livestock owners.

The University, spread over an area of 782.34 acres, is located in Mathura cantonment and is about 5 km from Mathura railway junction and 3.5 km from roadways bus stand. The main campus appears impressive with the buildings of College of Veterinary Science & Animal Husbandry, College of Biotechnology, College of Fisheries Science, College of Dairy Science, Institute of Para - Veterinary Sciences, Krishi Vigyan Kendra, University Library, Nand Bhawan, Referral Super-speciality Veterinary Hospital (Kothari Hospital), health centre, educational museum, four guest houses, eleven hostels, auditorium, gymnasium, helipad, residential colonies, herbal garden, nakshatra vatika, street lighting, independent water supply, primary school, medical shop, canteen, bank, ATMs and post office. In addition, the University, on its own campus, has Livestock Farm Complex (LFC) with more than 500 indigenous cows, Murrah and Nili Ravi buffaloes, goat farm having more than 600 goats of ten different breeds and poultry farm with more than 2500 birds, Go - Anusandhan Sansthan, horse stable with riding field and agriculture farm. The other agriculture farm of approximately 1400 acres is located at Madhuri Kund on Govardhan road about 30 km from the main campus.

Being located in "*Braj*", an area where cattle, symbolized by cow, are held in high esteem, the University is unique in having special responsibilities towards promoting cow husbandry through research and technological interventions.

Placement of the University alumni is a gold standard bench mark of the successful performance of any university. DUVASU has manifested its superiority by way of almost 100 per cent placement of its students in State animal husbandry departments, banks, private sectors, R&D, academic and research institutes, administrative services, Remount Veterinary Services and paramilitary forces like BSF, ITBP etc. DUVASU has come a long way in attaining the objectives for which it was established and is poised to touch the newer heights of performance and milestones of achievements. In recent years, the graduates of this college are coming with new start-ups in terms of small animal clinics and have become job providers than job seekers. During the last almost one decade, students of College of Veterinary Sciences and Animal Husbandry have been doing exceedingly well in All India Joint Entrance Examination for Post graduate scholarships/Junior Research Fellowship conducted by Indian Council of Agricultural Research, New Delhi.

Presently, degree programmes are going on in its four colleges, namely - College of Veterinary Science and Animal Husbandry, College of Biotechnology, College of Dairy Science and College of Fisheries Science. In addition to the degree programmes, two diploma programmes i.e., Diploma in Livestock Extension and Diploma in Veterinary Pharmacy are also going on since 2013 in the Institute of Para Veterinary Sciences. The University began a new chapter in its journey by staring with two new colleges- College of Dairy Science and College of Fisheries Science from the academic Year 2024-25. The University has signed Memorandum of Understanding (MoU) with Central Institute for Research on Goats (CIRG), Makhdoom; Indian Veterinary Research Institute (IVRI), Izatnagar; National Dairy Research Institute (NDRI), Karnal; NRC Meat, Hyderabad; NIAH, Baghpat; RAJUVAS, Bikaner; Central Council for Research in Homeopathy, New Delhi; CSWRI, Avikanagar; Sanskriti University, Mathura; IARI, New Delhi; NDVSU, Jabalpur; ICAR-CARI, Izatnagar and GBPUAT, Pantnagar etc. In addition, University is also having Memorandum of Understanding with Oklahoma State University, Oklahoma, USA; Purdue University, West Lafayette, Indiana, USA and International Training Centre on Pig Husbandry, Lipa City, Philippines. These MoUs with National and International institutes and Universities have enhanced the research and education opportunities and capabilities for students through their experienced faculty, educational opportunities and laboratory facilities.

The College has competent faculty to run the undergraduate and post graduate programmes. The College well equipped with the necessary facilities for teaching and research. Availability of excellent laboratory facilities and experienced faculty of College of Veterinary Science and Animal Husbandry is the added strength of the College of Biotechnology. The graduates of this college have been selected to different National Institutes of the country for their higher studies. The college has been reconstituted as per recommendations of V<sup>th</sup> Deans Committee report of the ICAR and will have five departments:

The college has been offering B.Sc. (Hons.) Biotechnology / Industrial Microbiology (6 semesters), however, as per the Vth Dean Committee report and subsequent discussion, necessary modifications has been done in course programme and from academic year 2023-2024, the College have been offering following academic programme:

In addition, College of Biotechnology is also offering a certificate course from academic year 2024-25 in 'Self Reliant Mushroom Farming'. For details of this course and admission as well as fee details, the candidates are advised to contact Dean, College of Biotechnology.

- iv) Dairy Microbiology
- v) Dairy Trade and Dairy Business Management
- vi) Pilot Dairy Unit cum Business Process Development Centre.

The College offers following two academic programmes:

- i. Bachelor of Technology (Dairy Technology): 4 years degree programme as per the VI<sup>th</sup> Deans committee report from the academic year 2025-26.
- ii. MSc./ M. Tech. (Dairy Science): Minimum 4 Semesters as per BSMA-2021 regulations of Indian Council of Agricultural Research (ICAR). The candidates with basic degree of BSc will be awarded MSc, while those with basic degree B. Tech will be awarded M. Tech.

## **INSTITUTE OF PARA-VETERINARY SCIENCE (Under Self-Finance Scheme)**

DUVASU takes pride in having started the need-based diploma courses in Veterinary Pharmacy and Livestock Extension in the state. These diploma programmes were started with the financial support under "Rashtriya Krishi Vikas Yojna" in College of Veterinary Science & Animal Husbandry in 2013 under self-finance scheme and since then, these programmes are going on successfully. Realizing the importance of livestock resources, veterinary education has been strengthened over the years, however, in view of the limited availability of qualified veterinary graduates, it is not possible for government to make their services available in each and every village. Further veterinary doctors too require well-trained supportive staff to cater the technical services more efficiently. Veterinary Pharmacists and Livestock Extension workers are essential for efficient veterinary services which include healthcare and management of livestock including artificial insemination services at village level. They also assist in public health services and control of zoonoses, endemics and epidemics under the guidance of expert veterinary professionals.

Therefore, in view of the requirements of trained human resource in the state of U.P., DUVASU decided to establish the Institute of Para-Veterinary Science. Recognizing the significance of trained manpower, Govt. of U.P through its notification no. 07/2024/I/798726/37-3099/8/2023 dated 18 Nov. 2024 has cited that diploma in livestock

extension is minimum essential qualification for appointment as livestock extension officer in Govt. of U.P. Similar notification is also expected for the post of Veterinary Pharmacist under department of animal husbandry in Govt. of U.P. Efforts are also going on to get this Institute fully-funded from Government of Uttar Pradesh so as to run the diploma programmes also on the similar lines as other academic programmes in College of Veterinary Science.

The Institute offers the following two academic programmes:

## Name of the programme Duration

1. Diploma in Veterinary Pharmacy (DVP) : 2 years 3 months.

2. Diploma in Livestock Extension (DLE) : 2 years.

### STUDENT'S AMENITIES

Facilities for indoor and outdoor games are available for students. There is a large play-ground in front of the main building of Veterinary College for outdoor games like cricket, hockey, football, volleyball, lawn-tennis, kabaddi, kho-kho. Apart from this, gymnasium with indoor facilities is available at campus. A large indoor badminton hall and squash court is also available. University organizes annual sports meet along with the cultural programmes. All the sports events are co-ordinated by Staff Counsellors. Dean Students Welfare is the overall Co-ordinating Officer and In-charge of all such programmes. Extra-curricular activities such as debates, declamation, quiz, essay writing competition and cultural activities are also organized from time to time.

**Tours:** Students are sent on compulsory educational tours to National Institutes and Universities as per the Academic Regulations.

**AKMU:** An Agricultural Knowledge Management Unit is available in the University. All the departments and offices of the University have internet connectivity through LAN System.

**Cafeteria/Canteen:** Cafeteria / Canteen facilities are available at the campus for students and staff of the University.

**Bank & Post Office:** Indian Overseas Bank with ATM facility and Sub-Post Office are also located in the main campus of the University. A State Bank of India ATM is also available on University Main Gate.

University Library: University library is housed in a three storeyed building with large number of books and relevant Indian and foreign journals. Library also has the facilities of photocopy machine and computers with internet connection. The library remains open from 10.00 A.M. to 7.00 P.M. A separate book bank also exists in the library with additional facility for the students of the weaker sections of the society.

**Students Welfare:** The Students Welfare setup in the University looks after the basic amenities for students and ensures facilities and services for personality development and for inculcating leadership qualities in them. Special emphasis is laid on discipline. Students effectively participate in the management of hostels, mess, games and sports, cultural and literary activities and other functions of the University from time to time.

**Hostels:** The University has eleven (6 Boys & 5 Girls) well-ventilated, neat and clean hostels for accommodating the students. Hostels are provided with Wi-Fi internet connectivity. Each hostel has common room facility with coloured television, newspapers and magazines. Indoor game facilities for Table-Tennis, Carom etc. are also available. Mess facility is available in all the University hostels. The hostels are managed by hostel wardens under the supervision of Dean Students Welfare (DSW). Hostel allotment is done as per the availability.

**Students Council:** The University has a student's council which includes the class representatives from different programmes. The President, Vice President, General Secretary and members of the council hold their office for one academic year. The student council participates in organization of all University events. Representatives of the council hold positions in different administrative committees of the University.

NCC and NSS: NCC/NSS is available for each and every student of University. The students have to compulsorily join 1 UP R & V Sqn. NCC or NSS. In addition to routine activities of NCC and NSS, they will also learn horse riding and participate in Republic day parade and various national level equestrian events. NCC cadets of R & V squadron have been bringing laurels to the University in national level events.

Communication Skills and Personality Development Programme: University engages outside experts for improving the communication skills of students and for their overall personality development.

**Post Graduate Scholarship Coaching Classes:** Every year for the benefit of students, JRF coaching classes are arranged by the University so that maximum students are able to qualify the All-India Agricultural Universities Joint Entrance Examination for Post graduate scholarship which is conducted by ICAR.

### **Merit Scholarships**

**B.V.Sc. & A.H.:** Three students of each B.V.Sc. & A.H. professional year are awarded University Merit Scholarship on the basis of their scholastic merit in their respective classes. Tuition fee of such students is also waived off.

All the students seeking admission through VCI are eligible for National Talent Scholarship of ICAR@ Rs. 3000/- pm., provided they are from the outside state.

**M.V.Sc.:** One scholarship of Rs. 1000/- pm is awarded to one student in each Department on the basis of merit. In addition, all the students seeking admission through ICAR common entrance test are eligible for National Talent Scholarship of ICAR @ Rs.5000/- pm, provided they are from state other than Uttar Pradesh.

**Stipend of the Social Welfare Department**: Students belonging to various constituent colleges/Institute of University are eligible to receive monthly stipend and fee refund as per the rules of Government of Uttar Pradesh.

## 2. Eligibility Criteria

### a. For BVSc and AH

- 1. He/ She should have passed 10+2 or equivalent examination with Physics, Chemistry, Biology/Biotechnology and English.
- 2. He/she has completed the age of 17 years on or before 31<sup>st</sup> December, 2025. Maximum age limit will be 25 years (age relaxation of 5 years for SC/ST/OBC candidates).
- 3. A candidate under Unreserved, OBC and EWS Category for admission to the Bachelor of Veterinary Science and Animal Husbandry degree course shall have to qualify in each of the subjects - English, Physics, Chemistry and Biology/Biotechnology, and obtained 50% marks in aggregate in these subjects in the qualifying examination and 47.5% (5% less than the qualifying marks for Unreserved and OBC category) for the candidates of SC & ST category.
- 4. For admission to B.V.Sc & A.H programme, the candidates will have to appear in UGEE-2025.
- 5. The selection of the students for admission to B.V.Sc. and A.H. degree course shall be only on the basis of his/her merit in the UGEE- 2025 examination conducted by DUVASU, Mathura and reservation as per the State/University Rules.
- 6. He/she must be domicile of Uttar Pradesh (Not in case of NRI/ OCI/PIO dependent /NRI sponsored candidates).
- 7. Candidates appearing in Intermediate Examination of 2025 are also eligible to appear in the UGEE-2025; however, their admission will also be governed by the above cited rules.
- 8. In the event of concealing any information or providing wrong information, admission will be cancelled.

- 9. All admissions shall be provisional in the first instance and the University reserves the right to cancel admission granted to a candidate without assigning any reason.
- 10. No person shall be entitled to claim any compensation or concession, if the admission granted is subsequently cancelled.
- 11. Candidates seeking admission under NRI/OCI/PIO dependent seat are those who are educated abroad and should have passed the subjects of Physics, Chemistry, Biology or Biotechnology and English up to the 12<sup>th</sup> Standard level with 50% aggregate marks in these subjects. NRI/OCI/PIO candidates are not required to appear in UGEE-2025, however, they must have secured minimum 50% marks in Intermediate or equivalent examination.
- 12. He/she shall produce his/her mark sheet/certificate of Intermediate Examination at the time of counselling.

### b. For B. Tech (Biotechnology)

### 4. UGEE-2025

The undergraduate entrance examination (UGEE-2025) will be conducted by DUVASU, Mathura for selection of candidates to Undergraduate Degree programmes.

For admission to UG degree programme the candidates will have to appear essentially in, UGEE-2025 which shall be conducted at different centres as may be notified by the University.

### 5. Admit Cards

Admit card for the Undergraduate Entrance Examination 2025 shall be downloaded from University website <a href="https://www.upvetuniv.edu.in">www.upvetuniv.edu.in</a>.

### **6. Examination Centres**

**UGEE-2025:** The UGEE 2025 will be conducted on following nine centres:

Bareilly, Gorakhpur, Jhansi, Kanpur, Lucknow, Mathura, Meerut, Prayagraj and Varanasi.

The candidate will be offered two choices for appearing in examination. However, one of the choices should be from Bareilly, Kanpur, Lucknow, Mathura, Gorakhpur and Varanasi.

(The University reserves the right to cancel any centre owing to logistical issues/ less number of candidates seeking a particular city centre. In such a case, the candidates shall have to appear in alternate centre allotted to him/ her and no claim shall be entertained for non-appearance in UGEE-2025 (on account of change in centre.)

### 7. VCI Seats

- a) These seats will be allotted by VCI through its own counselling based on criterion fixed by Veterinary Council of India.
- b) If these seats are not filled by VCI till last date of admissions, they will be filled by the University as per University rules.

## **8. Payment Seats for BVSc and AH** (Other than open and VCI seats)

- a) Candidates seeking admission in this category shall have to appear in the UGEE-2025 conducted by DUVASU, Mathura and qualify the same as per the University rules.
- b) Such candidates would be selected as per the merit list of UGEE-2025.
- c) Reservation policy of the Government of Uttar Pradesh will be applicable for payment seats as well.
- d) Payment seats lying vacant, if any from the reservation quota (EWS/ OBC/ SC/ ST), will be filled from the unreserved category candidates.
- e) Selected candidates shall have to pay Rs. 3.00 lacs in addition to the other fee applicable at the time of admission in 1<sup>st</sup> Professional of B.V.Sc. & A.H. For subsequent professionals (II and III), including repeat years (failure or drops) in all professionals (from I to III), such students shall have to pay Rs.1.5 lacs per professional year in addition to the other applicable fee/dues. Fee for routine 4<sup>th</sup> Professional (1.5 yrs) including repeat professional, on account of drop or failure, shall be Rs. 2.25 Lacs plus other normal fee.

## 9. NRI/ OCI/PIO dependent / NRI sponsored Seats for BVSc and AH

a) For admission to NRI/OCI/PIO/NRI sponsored category, the candidate need not be domicile of Uttar Pradesh.

- b) The candidates shall have to pay US \$ 8000.00 (or equivalent in Rupees) in addition to the normal fee at the time of admission in 1<sup>st</sup> Professional and US \$ 4000.00 (or equivalent in Rupees) at the beginning of each subsequent professionals including professionals repeated on account of failure or drops except in 4<sup>th</sup> Professional where the fee shall be US \$ 6000.
- c) Unfilled seats of NRI quota will be transferred to UR payment seats.
- d) NRI/OCI/PIO candidate will be given preference over NRI sponsored candidates.

### 10. Women/ Girls Seats

- a) The seats reserved for the girls in B.V.Sc. and A. H. program will be filled under the payment category as per the details given at 8 (e) and as per the merit in UGEE-2025 conducted by DUVASU, Mathura.
- b) The seats reserved for the girls in B.Tech (Biotechnology)/ B.F.Sc. / B. Tech (Dairy Technology) program will be filled as per the merit in the UGEE-2025 conducted by DUVASU, Mathura.
- c) Reservation policy of the Government of Uttar Pradesh will be applicable.
- d) Girls seats lying vacant, if any from the reservation quota (EWS/ OBC/ SC/ ST), will be filled from the unreserved category candidates (Girls).

### 11. University Employee Ward Seats

- a) Only spouse/children of regular employees of U.P. Pt. Deen Dayal Upadhyaya Pashu-Chikitsa Vigyan Vishwavidyalaya evam Go- Anusandhan Sansthan, Mathura (DUVASU) are eligible under this category.
- b) For claiming benefit of University Employee ward seat, the applicant has to submit due certificate from University.
- c) The seats reserved for DUVASU employee's wards in BVSc and AH program will be filled under the payment category as per the details given at 8 (e). However, a concession of 50% for class III and IV employees of this University will be allowed in fee i.e., a dependent of employee ward wherethe employee belongs to class III or IV, the candidate will pay a fee of Rs.1.5 lacs at the time of admission in first year in addition to normal fees. Similarly, a concession of Rs. 50000.00 for subsequent professional years except 4<sup>th</sup> Professional where a concession of Rs. 75000.00 will be allowed in addition to normal fees.
- d) Unfilled employee's wards seat in BVSc and AH program will be transferred to UR payment seats.
- e) Unfilled employee's wards seat in B.Tech (Biotechnology)/ B.F.Sc. / B. Tech (Dairy Technology) programs will be transferred to UR seats.

#### 12. Reservations

For admissions to B.V.Sc. and A.H., B. Tech. (Biotechnology), B.F.Sc. and B. Tech (Dairy Technology) following reservations will be followed in each programme. The reservation will be programme-wise

## Reservation for sub-categories is available from the main categories as given below:

(a) Children of Freedom Fighters : One seat (from any main category)

(b) Children of Defence Persons (Armed Forces) : One seat (from any main category)

(c) Physically Handicapped\* : One seat (from any main category)

The candidates claiming for any of the above reservation benefits shall have to submit the relevant certificate issued by the competent authority at the time of counselling.

\*Note: In Physically handicapped sub-category, a candidate shall not be allowed admission to Bachelor of Veterinary Science and Animal Husbandry degree course including those admitted under 15% reserved quota of Veterinary Council of India if he/she suffers with the following disabilities:

- (a) Disability of total body including disability of chest or spine more than 50%,
- (b) Disability of lower limb of more than 50%,
- (c) Disability of upper limb,
- (d) Visually handicapped candidates and those with hearing disability,
- (e) Candidates with progressive diseases like myopathies etc.
- (f) Disabilities which otherwise would interfere in the performance of the duties of a veterinarian.

The disability will be certified by a Medical Board constituted by Vice Chancellor of the University in consultation with Chief Medical Officer of Mathura District, comprising of at least three specialists out of which two should be of the specialty concerned and the candidate has to present him/herself before the Medical Board. The fee of the medical board will have to be borne by the candidate only.

### 13. Syllabus for UGEE-2025

The syllabus for UGEE-2025 will be as that of Intermediate of Uttar Pradesh Board/ CBSE or Equivalent.

### 14. Question Paper (Question booklet)

#### a. for UGEE-2025

The Question Booklet contains 200 questions serially numbered from 1 to 200. There will be
 50 questions each from Physics and Chemistry and 100 questions from Biology or
 Mathematics. The candidate will have to mark in choice of subject on OMR Sheet.

- The candidates aspiring for admission in BVSc and AH/ BFSc has to appear in subject of Biology, while candidates aspiring for admission in B. Tech. (Biotechnology)/ B. Tech (Dairy Technology) can appear either in subject of Biology or Mathematics.
- The OMR Answer sheet/Response sheet is inserted in each Booklet and each OMR sheet has 200 blank spaces serially numbered from 1-200 for filling the answers of respective questions. NO ADDITIONAL OMR SHEET SHALL BE PROVIDED. Candidates are advised to handle and fill it carefully.
- The Booklet is stapled, bound and sealed on three open sides with paper seals.
- Question Booklets are in four sets i.e. A, B, C & D.
- In case of any doubt, discrepancy, misprinting, missing pages etc., the candidate must bring it to the notice of the Invigilators within the first 5 minutes and get the question booklet replaced with the booklet of the same series set (A, B, C or D) before writing the answer.
- The rough work should be done only on the question booklets. Extra blank page is provided in question booklets for this purpose. Neither will he/she be given any separate paper nor will he/she use any of his/her own paper.
- There shall be four marks for each correct answer and one mark will be deducted for each incorrect answer. More than one answer indicated/marked against a question will be deemed as incorrect answer and will be negatively marked. Zero marks will be awarded for nonattempted question.
- Use only BLACK/BLUE BALL POINT PEN for writing and filling the circle(s) on the OMR answer sheet.
- Please read the instructions given in the question booklet in full before attempting the questions.
- The question paper will be in Hindi and English both, however, in case of any discrepancy English version of question paper will be considered to be final.

### 15. Answer Sheet

The answer sheet i.e., OMR will be provided with the Test Booklet. Candidates are advised to go through it and be fully conversant with the requirement of given particulars and marking the answers so that in the examination hall they could do so without any difficulty.

**Note:** No query regarding filling up of the test-booklets and answer sheets by the students will be entertained in the Examination Hall. The answer sheet used will be of special type, which will be scanned on Optical Scanner. There will be two sides of the Answer Sheet. Each answer circle on the sheet corresponds to the serial number of questions given in the Test Booklet. With each column, there are four circles bearing letters a, b, c and d which corresponds to the four responses, one of which is correct or most appropriate.

### 16. Writing of Answers or Responses

There will be four alternative answers for each of the question numbering from 01 to 200. The candidate will indicate his/her response to the question by **completely darkening the appropriate circle with BLACK/BLUE BALL PEN.** 

For example, question No. 55 in the Test Booklet reads as below:

College of Veterinary Science & Animal Husbandry of U.P. Pandit Deen Dayal Upadhyaya Pashu Chikitsa Vigyan Vishwavidvalaya evam Go Anusandhan Sannsthan is located at:

(a) Lucknow (b) Mathura (c) Bareilly (d) Kanpur

The correct answer to this question is (b) Mathura. The candidate will locate question No. 55 in the answer sheet (OMR sheet) and darken the circle (b) as shown below:



If the candidate does not want to attempt any question, he/she should not mark (darken) any of the circles given against that question.

The candidate must ensure that the answer sheet is not folded. He/she should not make any stray marks on it as it may discredit his/her OMR sheet during optical scanning for which the candidate would be responsible.

**Wrong/Incorrect way of marking:** If more than one circle is darkened or if the response is marked in the manner other than the required, it shall be treated as wrong way of marking the answer. A lightly, faintly or partly darkened or otherwise marked circle will be treated as wrong method of marking which will be rejected by the Optical Scanner.

## 17. Procedure to be followed in the Examination Hall:

- a) Only admit card and pen are allowed in the Examination Hall.
- b) Handbags, Mobile or Cell phone, pagers, digital watch, pen drives, calculators, cameras, tape recorders, pen scanners or any other communication or copying devices are not allowed inside the Examination Hall/Room.
- c) No candidate shall be allowed to enter the examination hall after 15 minutes of the commencement of Examination. Candidates who arrive late may be admitted to the examination hall at the discretion of the Centre Superintendents but in no case a candidate should be admitted who arrives more than 30 minutes after the commencement of the examination.
- d) Before answering the questions, candidates should write their correct roll number both in figures and words on the Question Booklet.
- e) On the front side of the OMR sheet, the candidate should write Roll number, category, subcategory, question booklet code, subject code as well as fill the circles correctly and

carefully. Any error in filling circles may lead to non-evaluation / wrong evaluation of OMR sheet

- f) On the back side (second side) of the OMR sheet (answer sheet), candidate should write his/her name, roll number and put his / her signature in the space provided as per application form and should be countersigned by the invigilator.
- g) Copying down questions by candidates on admit cards or any other material will disqualify them from the examination.
- h) No candidate shall be allowed to leave the examination hall/room before completion of the examination time. A candidate may be permitted to leave the hall/room only once for the purpose of toilet use after 60 minutes of the commencement of the examination with an escort.
- i) Before leaving the examination hall/room candidates must hand over the question booklet and the answer sheet (OMR) to the invigilator.
- j) Smoking and use of other intoxicants are strictly prohibited in the Examination Hall.
- k) University reserves all the rights to get candidates photography and/or videography and/or finger printing of the candidates during the examination for record and subsequent identification purposes. Any impersonation will be dealt with as per the law.

#### 18. Method of Selection

The admission shall be made strictly in order of merit - cum reservation based on the marks obtained by the candidate in the Undergraduate Entrance Examination. For admission to BVSc and AH/ B. Tech. (Biotechnology)/ B. F. Sc./ B. Tech. (Dairy Technology) merit list of UGEE-2025 will be followed.

In case of candidates having obtained equal marks in the entrance examination, their inter-se ranking shall be determined on the basis of the following:

- a) The aggregate percent of marks obtained by the candidates in Intermediate/ (10+2) examination.
- b) The aggregate of the percent marks obtained in science subjects (physics, chemistry, biotechnology/biology/mathematics) in Intermediate/ (10+2) examination.
- c) In case of the candidates, who have secured equal marks in aggregate at the qualifying examinations as well as in science subjects, and even other examinations up to high school examinations, the date of birth shall be the basis i.e., the candidate senior in age would rank higher for selection.

- a) If any seat of ICAR category is left unfilled, it will be filled by University through PGEE-2025.
- b) The University reserves right to increase number of seats in doctorate programme in a particular discipline by shifting of seats left vacant in different discipline. The shifting of seats in different disciplines will be decided by the Committee constituted by Vice-Chancellor. The Committee after assessing the availability of required faculty and facilities will make recommendation. The recommendation of the Committee shall be put up to Vice-chancellor for approval.
- c) For In-Service Candidates, one seat in each department will be increased for the Ph.D. programme over and above the number shown in above table. However, seats may be increased based on the availability of teachers, recommendations of the Head of the Department and approval of the competent authority of the University.

- ii. For admission on Masters Programme of Veterinary Sciences, the candidate must have passed the B.V.Sc & A.H. examination from a VCI recognized veterinary college. The applications of employed candidates must be routed through their employer, failing which the same will not be entertained.
- iii. Eligibility for Masters Programme (in College of Veterinary Science and AH) is BVSc and AH with 6.000/10.000 or equivalent OGPA/equivalent percentage of marks for unreserved, OBC and EWS category candidates and 5.500/10 or equivalent OGPA/equivalent percentage of marks for SC/ST/PH category candidates.
- iv. Eligibility for MSc Programme (in College of Biotechnology) is Bachelor's degree in any branch of life sciences/ Biological Sciences (Botany, Zoology, Biotechnology, Biochemistry, Microbiology, Genetics and Biomedical Sciences) with 6.000/10.000 or equivalent OGPA/ equivalent percentage of marks for un-reserved, OBC and EWS category candidates and 5.500/10 or equivalent OGPA/equivalent percentage of marks for SC/ST/PH category candidates or Equivalent degree from recognized university with

- atleast 60% marks in aggregate for un-reserved, OBC and EWS category candidates (55% in case of SC/ST/PH candidates)
- v. Eligibility for MVSc Programme (in College of Biotechnology) is Bachelor's degree in Veterinary Science with 6.000/10.000 or equivalent OGPA/equivalent percentage of marks for un-reserved, OBC and EWS category candidates and 5.500/10 or equivalent OGPA/equivalent percentage of marks for SC/ST/PH category candidates Or Equivalent degree from recognized university with atleast 60% marks in aggregate for un-reserved, OBC and EWS category candidates (55% in case of SC/ST/PH candidates)
- vi. Eligibility for M. Tech Programme (in College of Biotechnology) is 4 years Bachelor's degree in Engineering with biology or related subject as one of the papers at the 10+2 level or later with 6.000/10.000 or equivalent OGPA/equivalent percentage of marks for un-reserved, OBC and EWS category candidates and 5.500/10 or equivalent OGPA/equivalent percentage of marks for SC/ST/PH category candidates or Equivalent degree from recognized university with atleast 60% marks in aggregate for un-reserved, OBC and EWS category candidates (55% in case of SC/ST/PH candidates)
- vii. - viii. For admission in Master Programme (M.F.Sc in Aquaculture), the candidate must have passed a minimum of 4 year degree programme (Bachelor of Fisheries Science) with 6.000/10.000 or equivalent OGPA/equivalent percentage of marks for un-reserved, OBC and EWS category candidates and 5.500/10 or equivalent OGPA/equivalent percentage of marks for SC/ST/PH category candidates from a recognized University.
- ix. Eligibility for Doctorate programme (in College of Veterinary Science and AH) is MVSc in the concerned subject with an OGPA of 6.500/10.000 or equivalent percentage of marks for un-reserved (UR), OBC and EWS category candidates and 6.000/10.000 for SC/ST/PH category candidates.
- x. Eligibility for Doctorate programme (in College of Biotechnology) is Master degree (M.Sc. or M. Tech.) in any branch of science related to Biotechnology and bioinformatics such as Chemistry/ Biology/ Life Sciences/ Microbiology/ Biotechnology/ Biochemistry/ Plant and Environmental science/ Pharmacy/ Agricultural Science/ Pharmaceutical Science/ MVSc with an OGPA of 6.500/10.000 or equivalent percentage of marks for un- reserved (UR), OBC and EWS category candidates and 6.000/10.000 for SC/ST/PH category candidates.
- xi. OGPA or equivalent percentage of marks for SC/ST/PH category as per the guidelines of ICAR. Conversion formula for OGPA calculation shall be of the respective university and of the same year in which the candidate has obtained degree. For this, the candidate will have to submit the same in form of a certificate duly authenticated by Registrar/Dean of the concerned University.
- xii. Admission to all Post-graduate programmes shall be made strictly on the basis of merit in the Post Graduate Entrance Examination 2025 (PGEE-2025) conducted by DUVASU, Mathura.
- xiii. Mere appearance/ qualifying/ merit in PGEE-2025 does not make the candidate eligible for admission in Post graduate courses unless he/she has not passed the undergraduate degree on the date of registration.
- xiv. The candidate will have to produce certificate of qualifying the pre-requisite degree on the date of counselling.   - ix. There will be four alternative answers for each of the question numbering from 01 to 100. The candidate will indicate his/her response to the question in the provided space.
  - x. The rough work should be done only on the question booklets. Extra blank page is provided in question booklets for this purpose. Neither will he/she be given any separate paper nor will he/she use any of his/her own paper.

### d. Procedure to be followed in the Examination Hall

- i. Only admit card and pen are allowed in the Examination Hall.
- ii. Handbags, Mobile or Cell phone, pagers, digital watch, pen drives, calculators, cameras, tape recorders, pen scanners or any other communication or copying devices are not allowed inside the Examination Hall/Room.
- iii. No candidate shall be allowed to enter the examination hall after the 15 minutes of commencement of the Examination. Candidates who arrive late may be admitted to the examination at the discretion of the Centre Superintendents but in no case a candidate should be admitted who arrives more than 30 minutes after the commencement of the examination.
- iv. Before answering the questions, candidates should write their correct Roll Number both in figure and words on the Question Booklets and ensure his/her Signature. Any error in this will lead to non-evaluation of answer sheet.
- v. Answer sheet should be countersigned by the invigilator.
- vi. Copying down questions by candidates on admit cards or other material will disqualify them from the examination.
- vii. No candidate shall be allowed to leave the examination hall/room before completion of the examination time. A candidate may be permitted to leave the hall/room only once for the purpose of toilet use after 60 minutes of the commencement of examination with an escort.

(i) Admission to Masters programmes: The admission to master's programme shall be made strictly in order of merit - cum reservation based on the marks obtained by the candidate in the Postgraduate Entrance Examination i.e., PGEE-2025.

In case of candidates having obtained equal marks in the entrance examination, their inter-se ranking shall be determined on the basis of the following:

- a) The aggregate percent of marks obtained by the candidates in Undergraduate degree examination.
- b) The aggregate percent of marks obtained by the candidates in Intermediate/ (10+2) examination.
- c) The aggregate of the percent marks obtained in high school examination.
- d) In case of the candidates, who have secured equal marks in aggregate at the qualifying examinations, and even other examinations up to high school examinations, the date of birth shall be the basis i.e., the candidate senior in age would rank higher for selection.

(ii) Admission to doctorate programmes: In subjects where PGEE-2025 is conducted for admission to PhD programme the admission shall be made strictly in order of merit - cum reservation based on the marks obtained by the candidate in the Postgraduate Entrance Examination i.e., PGEE-2025.

In case of candidates having obtained equal marks in the entrance examination, their inter-se ranking shall be determined on the basis of the following:

- a) The aggregate percent of marks obtained by the candidates in Postgraduate degree examination.
- b) The aggregate percent of marks obtained by the candidates in Undergraduate degree examination.
- c) The aggregate percent of marks obtained by the candidates in Intermediate/ (10+2) examination.
- d) The aggregate of the percent marks obtained in high school examination.
- e) In case of the candidates, who have secured equal marks in aggregate at the qualifying examinations, and even other examinations up to high school examinations, the date of birth shall be the basis i.e., the candidate senior in age would rank higher for selection.

However, if in any subject the number of candidates seeking admission in PhD in any particular subject is less than the number of seats declared, then in that case the admission to such subject will be made on the basis of merit of qualifying examination. In case of candidates having obtained equal marks in the qualifying examination, their inter-se ranking shall be determined on the basis of the following:

### 2. Eligibility Criteria

a) He/she has completed the age of 17 years on or before 31<sup>st</sup> December, 2025. Maximum age limit will be 25 years (age relaxation of 5 years for SC/ST/OBC candidates).

- b) He/ she has passed the qualifying examination (10+2 or intermediate from U.P. Board or equivalent) with Physics, Chemistry, Biology/Biotechnology and English with 50% aggregate marks for Unreserved and OBC candidates and 45% aggregate marks for SC/ST candidates or an examination equivalent to the intermediate examination of an Indian University/Board recognized by the Association of Indian Universities taking Physics, Chemistry, Biology and English.

### 7. Syllabus for DEE -2025

The syllabus for DEE-2025 will be as that of the Intermediate Examination of UP Board/Equivalent.

### 8. Question Paper (Question booklet)

- i. The Question Booklet contains 200 questions serially numbered from 1 to 200. The questions shall be framed from Physics, Chemistry and Biology containing 50 questions each from Physics and Chemistry and 100 questions from Biology.
- ii. The OMR Answer sheet/Response sheet is inserted in each Booklet and each OMR sheet has 200 blank spaces serially numbered from 1-200 for filling the answers of respective questions. NO ADDITIONAL OMR SHEET SHALL BE PROVIDED. Candidates are advised to handle and fill it carefully.
- iii. The Booklet is stapled, bound and sealed on three open sides with paper seals.
- iv. Question Booklets are in four sets i.e. A, B, C & D.
- v. In case of any doubt, discrepancy, misprinting, missing pages etc., the candidate must bring it to the notice of the Invigilators within the first 5 minutes and get the question booklet replaced with the booklet of the same series set (A, B, C or D) before writing the answer.
- vi. The rough work should be done only on the question booklets. Extra blank page is provided in question booklets for this purpose. Neither will he/she be given any separate paper nor will he/she use any of his/her own paper.
- vii. There shall be no negative marking.

- viii. Use only **BLACK/BLUE BALL POINT PEN** for writing and filling the circle(s) on the OMR answer sheet.
- ix. Please read the instructions given in the question booklet in full before attempting the questions.

## 9. Answer Sheet

The answer sheet i.e., OMR will be provided with the Test Booklet. Candidates are advised to go through it and be fully conversant with the requirement of given particulars and marking the answers so that in the examination hall they could do so without any difficulty.

**Note:** No query regarding filling up of the test-booklets and answer sheets by the students will be entertained in the Examination Hall. The answer sheet used will be of special type, which will be scanned on Optical Scanner. There will be two sides of the Answer Sheet. Each answer circle on the sheet corresponds to the serial number of questions given in the Test Booklet. With each column, there are four circles bearing numbers a, b, c and d which correspond to the four responses, one of which is correct or most appropriate.

### 10. Writing of Answers or Responses

There will be four alternative answers for each of the question numbering from 01 to 200. The candidate will indicate his/her response to the question by **completely darkening the appropriate circle with BLACK /BLUE BALL PEN.** 

For example, question No. 55 in the Test Booklet reads as below:

College of Veterinary Science & Animal Husbandry of U.P. Pandit Deen Dayal Upadhyaya Pashu Chikitsa Vigyan Vishwavidvalaya evam Go Anusandhan Sansthan is located at:

(a) Lucknow (b) Mathura (c) Bareilly (d) Kanpur

The correct answer to this question is (b) Mathura. The candidate will locate question No. 55 in the answer sheet and darken the circle (b) as shown below:



If the candidate does not want to attempt any question, he/she should not mark (darken) any of the circles given against that question.

The candidate must ensure that the answer sheet is not folded. He/she should not make any stray marks on it as it may discredit his/her OMR sheet during optical scanning for which the candidate would be responsible.

**Wrong/Incorrect way of marking:** If more than one circle is darkened or if the response is marked in the manner other than the required, it shall be treated as wrong way of marking the answer. A lightly, faintly or partly darkened or otherwise marked circle will be treated as wrong method of marking which will be rejected by the Optical Scanner.

#### 11. Procedure to be followed in the Examination Hall:

- a) Only admit card and pen are allowed in the Examination Hall.
- b) Handbags, Mobile or Cell phone, pagers, digital watch, pen drives, calculators, cameras, tape recorders, pen scanners or any other communication or copying devices are not allowed inside the Examination Hall/Room.
- c) No candidate shall be allowed to enter the examination hall after 15 minutes of the commencement of Examination. Candidates who arrive late may be admitted to the examination hall at the discretion of the Centre Superintendents but in no case a candidate should be admitted who arrives more than 30 minutes after the commencement of the examination.
- d) Before answering the questions, candidates should write their correct Roll Number both in figures and words on the Question Booklet and Roll Number, Category, Sub-category and Code of question booklet and mark proper circles on front side of OMR sheet and on second side put up their Name and Signature. Any error in this will lead to non-evaluation of the OMR sheet.
- e) On the back side of the OMR sheet (answer sheet), candidate should write his/ her name and put his / her signature in the space provided as per application form and should be countersigned by the invigilator.
- f) On the front side of the OMR sheet, the candidate should write Roll number, category, sub-category, question booklet code as well as fill the circles correctly and carefully. Any error in filling circles may lead to non-evaluation / wrong evaluation of OMR sheet
- g) Copying down questions by candidates on admit cards or any other material will disqualify them from the examination.
- h) No candidate shall be allowed to leave the examination hall/room before completion of the examination time. A candidate may be permitted to leave the hall/room only once for the purpose of toilet use after 60 minutes of the commencement of the examination with an escort.
- i) Before leaving the examination hall/room candidates must hand over the question booklet and the answer sheet (OMR) to the invigilator.
- j) Smoking and use of other intoxicants are strictly prohibited in the Examination Hall.

### 12. Method of Selection

The admission shall be made strictly in order of merit based on the aggregate marks obtained by candidate in DEE-2025. In case of candidates having obtained equal marks in the entrance examination, their inter-se ranking shall be determined on the basis of following:

a) The aggregate percent of marks obtained by the candidates in Intermediate/(10+2) examination.

- b) The aggregate of the percent marks obtained in science subjects (physics, chemistry, Biotechnology/biology) in Intermediate/(10+2) examination.
- c) In case of the candidates, who have secured equal marks in aggregate at the qualifying examinations as well as in science subjects, and even other examinations up to high school examinations, the date of birth shall be the basis i.e., the candidate senior in age would rank higher for selection.

### **D. COUNSELLING:**

The university will strive to conduct counselling in online mode. However, if required the counselling will be conducted in offline mode at University headquarters. The information will be provided on University website. The candidates are strongly advised to view University website regularly for updates.

- 1. Offline Counselling: The University will conduct Offline counselling which can be in multiple rounds. The individual candidates will have to regularly check for updates on University website for relevant information. If offline counselling is conducted, the candidate will have to pay counselling fees of Rs. 500.00 only at the counter for this purpose on the day of counselling.
- **2. Online Counselling:** The University will attempt to conduct online counselling, for which detailed guidelines will be placed on website. The candidates are strongly advised to visit the university website regularly and keep themselves abreast with the information. No complaint/petition will be entertained on account of this. If online counselling is conducted, following will be the brief guidelines:
  - a) There will be two stages of Counselling. First Stage will be Online counselling which will be conducted in various rounds. The second stage will be Offline counselling which will be conducted at University headquarters.
  - b) Online Counselling will be done for admission to all programmes.
  - c) The schedule and other details will be made available on University website as the result of UGEE-2025/ PGEE-2025/ DEE-2025 will be declared.
  - d) The candidate will keep themselves updated by frequently visiting the University website for details and procedure of counselling whenever declared.
  - e) The University will not send individual notice of counselling to any candidate.
  - f) No appeal shall be entertained for non- participation in counselling on want of non-information on part of University.
  - g) For online counselling, interested candidate will have to login on University website after declaration of Result (UGEE/PGEE/DEE) and pay a counselling fees of Rs. 500.00 only {plus Payment Gateway (PG) charges, if any}. This payment will be by online mode only and will be non-refundable.

- h) The online counselling will be conducted in different stages and candidates will have to participate in various stages for allotment of seat. The seat will be allotted according to choice filled, merit and category.
- i) The allotment of seat will be provisional and will be subject to deposition of seat acceptance fee of Rs. 5000.00 (plus PG Charges, if any) at the time of allotment. The deposition of fees will be in online mode only.
- j) On deposition of seat acceptance fee, the candidate will get the option of either remaining at the same seat or apply for upgradation.
- k) For consideration of candidature for seat upgradation, deposition of seat acceptance fees is essential.
- The confirmation of provisional admission will be subject to subsequent verification of documents at the time of admission.
- m) If any candidate does not deposit the seat acceptance fees or is not able to deposit seat acceptance fees due to any reason (including transaction failure), the allotment of seat will be cancelled automatically and no appeal will be entertained for the same.
- n) The seat acceptance fee will be adjusted against final payment at the time of admission. However, if the admission is not finally granted due to lack of documents or misrepresentation of facts by the candidate the seat acceptance fee will not be refunded nor adjusted for any other candidate and will stand forfeited.
- o) After completion of online counselling, a round of offline counselling will be conducted at University campus on the date declared.
- p) Candidates who have participated in online counselling but could not get admission will be eligible to participate in Offline counselling on seats left vacant. The admission will be granted subject to merit, choice of course, and category; production of appropriate certificates and deposition of fees. The details including procedure and fees etc., about the offline counselling will be shared on University website.
- q) If required, a mop-up round of counselling will be conducted after offline counselling. The mop-up round will be in offline mode and will be conducted at University headquarters. The details including procedure and fees etc., about the mop-up round counselling will be shared on University website.

#### 3. Documents to be produced at the time of counselling:

The candidates will have to essentially produce following documents:

- a) Certificate to the effect that He/ She have passed 10+2 or equivalent examination with Physics, Chemistry, Biology/Biotechnology/ Mathematics and English from recognized board.
- b) Statement of marks of 10+2 or equivalent examination with Physics, Chemistry, Biology/Biotechnology/ Mathematics and English from recognized board.

- c) Xth class/ Equivalent certificate from relevant board of examination stating the date of birth
- d) Domicile certificate duly issued by the competent authority
- e) Category certificate in case of SC /ST/ OBC / EWS Category duly issued by the competent authority.
- f) Subcategory certificate in case of PH/FF/AF duly issued by the competent authority
- g) Certificate from employer in case of University employee ward.
- h) Income certificate duly issued by the competent authority
- i) For NRI/OCI/PIO dependent candidate: Original and Photocopy of the relevant certificate
- j) For NRI sponsored candidates- letter from the sponsorer (In original and photocopies), passport of sponsorer (Photostat and attested copy) and proof of residence of sponsorer (Photostat and attested copy).
- k) For candidates seeking admission in PG/ PhD courses, candidate will have to produce the certificate that he/ she has passed the pre-requisite degree examination. However, if the candidate is yet to complete the qualifying degree requirements on date of counselling he/she will be granted provisional admission based on the certificate from Registrar/ Dean, of his/her place of study, stating that 'he/she is expected to complete the requirements of pre-requisite degree before the date of registration (\_\_\_\_\_\_\_) (mention date of completion of degree)'.

#### E. MEDICAL EXAMINATION:

- a) All the candidates desirous of seeking admission will have to undergo medical examination at the time of admission.
- b) The medical examination will be conducted at the University headquarters at the time of admission/counselling.
- c) The medical certificate will be as per the proforma given in the prospectus.
- d) The fees for same will be Rs. 100.00 per candidate and will be borne by the candidate, which will be realized along with the admission fees and paid to CMO/MO nominated by CMO, Mathura on production of bill for the same by CMO/MO

#### F. FEE STRUCTURE AND DEPOSITION

#### 1. Application Fee Deposition:

- a) The Application processing fees for UGEE/PGEE/DEE is non-refundable.
- b) The candidate will have to submit separate application form for UGEE/PGEE/DEE.
- c) The fees will be paid online and no-other mode of fee payment is accepted.

#### 2. Course Fees Deposition:

a. The admission to all courses will be through admission test and subsequent online/offline counselling.

- b. The schedule and procedure for online counselling will be circulated through University website. The candidates are advised to check website regularly for details and updates.
- c. The candidate will have to deposit seat acceptance fees during the online counselling.
- d. If the candidate subsequently does not take admission on the seat allotted, the seat acceptance fees will be forfeited and in no case refunded.
- e. If the candidate takes admission on the seat allotted, the seat acceptance fees will be adjusted towards the fees to be deposited by the candidate.
- f. If the candidate is upgraded according to his/ her choice and merit, the candidate will have to deposit the fees according to the seat freshly allotted to the candidate. If the fees of the fresh seat allotted to the candidate is lower than the original seat allotted then, he need not to deposit fees, however, the fees will be adjusted in next semester/ professional year.
- g. If any candidate withdraws his/ her candidature from University before the date of offline counselling, 90% of total fees (excluding candidates admitted on payment/ girls/ UEW and NRI/ NRI sponsored seats) will be refunded.
- h. If any candidate granted admission on payment/ girls/ UEW and NRI/ NRI sponsored seats, and subsequently withdraw from University before the date of offline counselling, only 50% of payment/ girls/ UEW and NRI/ NRI sponsored fees and 90% of normal fees will be refunded.
- i. However, if the candidate withdraws from University after the date of offline counselling, only Caution money, Library security and Hostel security will be refunded.

#### 3. Fees Deposition for continuing students:

- a. The fees will have to be deposited by all the students at the beginning of each semester/ professional year at the time of registration of semester/ professional year as the case may be.
- b. However, candidates belonging to SC/ST category will have to produce the freeship card at the time registration of the semester/ professional year from second year of their study onwards as per the rules and directions of the Govt. of UP.
